1.2 Purpose and Intended Audience of this Document

This document is a HL7 Conformance Statement for the HL7 Services of Agfa HealthCare Engage Suite 3.6, further referred to as 'Engage Suite' throughout the rest of this document.

The user of this document is involved with system integration and/or software design. We assume that the reader is familiar with the terminology and concepts that are used in HL7 standard and the IHE Technical Framework.

Readers not familiar with HL7 terminology should first read the appropriate parts of the HL7 standard itself, prior to reading this conformance statement.

Although the use of this conformance statement in conjunction with the HL7 standard is intended to facilitate communication with Engage Suite, it is not sufficient to guarantee, by itself, the inter-operation of the connection between Engage Suite and the 3rd party HL7-based system.
